#### 1. License.

The software and any parts accompanying this License whether on disk, in read only memory or any other media (the "Software") are sub licensed, not sold, to you for use only under the terms of this Software License Agreement ("License"). You own the media on which the Software is recorded but TOPOFLIGHT and/or TOPOFLIGHT's licensor (TOPOFLIGHT) retain title to the Software. The Software in this package and any copies, which this License authorizes you to make, are subject to this License.

#### 2. Grant of License.

Subject to the restrictions in Section 3, TOPOFLIGHT hereby grants to you the following non-exclusive rights in respect of the Software subject to your fulfillment of the relevant criteria. The rights granted to you are personal and non-transferable. Your rights under this License will terminate automatically without notice from TOPOFLIGHT if you fail to comply with any term(s) of this License.

##### 2.1. Updates and improvements.

#### 7. Export Rules.

The Software is subject to Swiss export laws and regulations. You must comply with all Swiss and international export laws and regulations that apply to the Software, including its components. #### 8. Third Party Software.
